TARMACKING OF KIBWEZI-KITUI ROAD

KWA kuwa kupanuka kwa biashara baina ya Mkoa wa Pwani na Mkoa wa Mashiriki kumetatizika kwa sababu ya ukosefu wa barabara madhubuti, Bunge hili linauliza Serikali itafute fedha za kuweka lami barabara ya Kibwezi-Kitui hadi Kangonde, haraka iwezekanavyo.

(Resumption of debate interrupted on 15.10.97)

Mr. Deputy Speaker: Hon. Kiliku, had your Motion been moved?

Mr. Kiliku: Yes, Mr. Deputy Speaker, Sir. **Mr. Deputy Speaker**: Who was on the Floor?

Mr. Kiliku: Dr. Kituyi!

Mr. Deputy Speaker: Dr. Kituyi was on the Floor and he is not here. He had a balance of 5 minutes. Anybody else who wants to speak? Hon. Mwavumo, it is your time now.

Mr. Mwavumo: Bw. Naibu Spika, katika kuiunga mkono Hoja hii, ningependa kusema kwamba ni muhimu sana kuwa na biashara baina ya Mkoa wa Pwani na Mkoa wa Mashariki. Barabara hizi zitaongezea biashara, na si biashara peke yake, bali pia kudumisha usalama wa sehemu zote hizi kutoka Mkoa wa Pwani hadi Mkoa wa Mashariki. Tukiwa na barabara nzuri ambazo zinaweza kupitika kwa magari, sehemu hizo zote zitakuwa na usalama na biashara zitaweza kupanuka. Tunategemea sehemu za mashariki katika kusitawisha barabara, kuinua utalii na biashara. Usalama utapatikana ikiwa barabara za sehemu zile zitakuwa nzuri.

Bw. Naibu Spika, hali ya usalama ni mbaya sana kwa sababu ya barabara mbovu. Magari yakiharibika, majambazi wanawaumiza watu na biashara haziwezi kuendeshwa vizuri kwa sababu ya ukosefu wa barabara nzuri. Ni mwito wetu kuwa na barabara imara ambazo zitasaidia kukuza biashara na usalama wa maeneo hayo. Eneo la Ukambani lina sehemu nyingi ambazo zinaweza kuwavutia watalii, lakini kwa sababu ya hali mbaya ya barabara na ukosefu wa usalama, biashara na utalii haziwezi kupanuliwa. Kwa hivyo, ni wajibu wa Serikali kuona kwamba barabara hizo zimetengenezwa ili kuinua utalii na biashara kati ya Mkoa wa Pwani na Mkoa wa Mashariki. Mkoa wa Mashariki una vitu vingi ambavyo vinaweza kutumika katika Mkoa wa Pwani na kuna utalii ambao unaweza kukuzwa. Licha ya hayo, hali ya usalama imezorota sana kiasi kwamba mtu hawezi kutembea kwa kuhofia kwamba gari lake likiharibika, hatapata usalama. Ni muhimu kuona kwamba Hoja hii imepitishwa ili kuweza kukuza kiwango cha utalii.

Kwa hayo machache, Bw. Naibu Spika, ninaunga mkono.

An hon. Member: Hakuna mtu!

Mr. Deputy Speaker: It is now time for the Mover to reply Mr. Kiliku!

Mr. Kiliku: Bw. Naibu Spika, kwanza ninawashukuru wale waheshimiwa Wabunge wote ambao waliunga mkono Hoja hii na pia ninaishukuru Serikali kwa kukubaliana na Hoja hii vile ilivyo. Pia, Serikali ilisema kwamba licha ya kuweka lami barabara ya Kibwezi-Kitui, itaweka lami hadi Kangonde kwa maana unaweza kwenda Thika au Garissa ukitumia barabara hiyo hiyo. Tunapozungumza hapa sasa, barabara nyingi kule Pwani hazipitiki. Kwa mfano, Jumamosi iliyopita tulikuwa Malindi na Mwenyekiti wa DP lakini hatukuweza kufika Marafa kwa sababu ya mvua nyingi iliyomo sehemu hiyo. Ingawa ile barabara ya Hola inayotengenezwa haijakamilika, kule walipoanza kuitengeneza, Malindi, imeanza kuharibika. Nilipopita Kilifi niliona vile maji yalivyo mengi karibu na Mtondia. Niliponea chupuchupu kwa sababu nilipopita, baada ya masaa mawili, ile daraja niliyopitia iliharibika. Hata Waziri wa Serikali hakuweza kufika katika kikao cha KANU. Alipelekewa heliktopta ili aweze kuvuka na wananchi wakaachwa wakihangaika. Ile heliktopta ingekuwa inafanya kazi kule ya kuokoa watu.

Pale Bombolulu, Bamburi Cement Factory, wanafuga mamba. Mamba hawa wametoka katika mazingira yao na kuingia katika vijiji kwa sababu kuna maji mengi. Mamba wengine wameingia katika nyumba za watu wakifikiria kwamba wako baharini. Na kule Changamwe, barabara zimeharibika na nyumba kuanguka. Watu wengi wamekufa. INTRODUCTION OF LEGISLATION TO PROTECT RESEARCH LAND

Prof. Mzee: Mr. Deputy Speaker, Sir, on behalf of Dr. Kituyi, I beg to move the following Motion: THAT, being conscious of the fact that research is the foundation of sustainable agricultural and livestock policy; determined to nurture research in appropriate seeds and animals for the sake of current population of our country and the posterity; committed to the protection of the limited land available for public research into livestock and crop strains under the Kenya Agricultural Research Institute; pained by the uncontrolled subdivision and disposal of research farms currently under way across the country, this House resolves to condemn all cases of disposal of research land to private interests, and calls upon the Government to introduce legislation to this House for the permanent banning of the practices of selling research land.

Mr. Deputy Speaker, Sir, I wish to move this Motion on behalf of Dr. Kituyi.

Mr. Deputy Speaker: Do you have any written instructions to move it on behalf of Dr. Kituyi?

Prof. Mzee: Mr. Deputy Speaker, Sir, I do not have any written instructions.

"A Member who has a Motion standing may authorize in writing some other Member to move that Motion in his stead."
